Power: There will be 110/20amp service and limited 30-50amp service for food service trucks. Note any power or special requirements here:

Set Up: Friday 12pm – 7pm and Saturday 7am-11am. Show Hours: Saturday 12noon-6pm. Vendors will have event vehicle admission passes for load in. Wristbands will be required for staff to be picked up at the Volunteer entrance. All vendors must be loaded in no later than Saturday by 9am. Gates for set up will open at times listed above. (Exceptions only by advance approval.) Arrival times are critical as food vendors will be located WITHIN the event-controlled security fencing area.

Food vendors that do not have a Kendall County annual permit are required to have 3-day temporary food vending permit (\$25). (We will register and pick up permits for you.) Food Vendors must submit a signed copy of Kendall County Temporary Food Establishment Compliance form (located on website) and State Food Handlers permit with their application. All applications with fees are due no later than September 5th or \$25.00 late fee will apply. A copy of the vendor proof of liability insurance should be included.

Vendor parking is located at the Fairgrounds lot Friday and Saturday across the street from the event. **Vendor breakdown or parking within the AgriCultural prior to 7pm on Saturday is prohibited.** Mis-parked vehicles are subject to ticketing or towing at owners' expense. Observe all traffic signs. The event site is fenced with limited access.
